Decision relating to the determination of Charges in relation to the
Airport of Rodos "Diagoras"

Following the notification of the justified proposal for specific changes on the charges of the Airport of Rodos "Diagoras" (RHO), as such were determined pursuant to the decision dated 30th January 2025, and following the consultation session that took place on 10th of December 2026 pursuant to the provisions of the Presidential Decree 52/2012 and

- (a) on the basis of the exchange of views with all involved parties, during the whole consultation process with regards to the changes of airport charges, the needs for readjustment of the charges according to the operational conditions of the Airport and the relevant needs for recovery of cost, as such needs have been presented in the aforementioned consultation session;
- (b) taking into account and the letter received by a user dated 16th January 2026 raising its objections against the proposed charges, which we considered and found not to be substantiated for the following reasons:
 - a. Level of detail of the information provided to Users: apart from the vagueness of the complaints raised regarding the information provided to Users, all the material related to the consultations has been provided to Users in accordance with Article 4 of Presidential Decree 52/2012. All objections raised during the consultation session were answered in detail, as can be seen from the relevant minutes and the message of the Airport Managing Body dated 19th December 2025. In any case, the level of analysis of the information provided to Users is sufficient and in line with the requirements of Presidential Decree 52/2012 and EC Directive 2009/12, as it demonstrates the correspondence between the fees imposed and the cost of the services and facilities provided to Users.
 - b. Proposed fee increase from 1st April 2026: the objections raised regarding the proposed increase in certain fees, in addition to being vague, are also unfounded, as the proposed increases to be implemented from 1st April 2026 are within the framework of inflation, are consistent with the provisions of article 28 and Annex 7 of the Concession Agreement, the PD 52/2012 and the EC Directive 2009/12, cover the increased cost of services and facilities provided to Users. In this context, Users will continue to pay only for services and facilities provided to them, while the allocation by category of charge follows the usual practices of the aviation community.
 - c. Website update: due to a technical issue, the invitation for the regular consultation did not appear on the website of the Airport Managing Body before the scheduled regular consultation meeting, but it has now been restored. In any case, this does not affect matters here, because the invitation for the extraordinary consultation had been sent to all Users through the Users' Committee, and the said user additionally received all the material following relevant communication with the Airport Managing Body. Therefore, the user had timely received the complete material for the extraordinary consultation and did not suffer any harm.

The changes on the Charges of the Airport that shall enter into force from 1st April 2026

are as follows:
