

Personal Data Protection/Privacy Statement

This Statement explains how Fraport Greece, in its capacity as Data Controller, processes your personal data in the context of a contest (hereinafter "Contest").

Who we are

(hereinafter "Fraport Greece" or "We"). For the purposes of this Contest, we act as Data Controller of your personal data and comply with our obligations under the relevant European (General Data Protection Regulation (EU) 2016/679 or "GDPR") and national legislation (L. 4624/2019).

The personal data we collect

If you wish to participate in the Contest, Fraport Greece collects and processes your personal data necessary for the implementation of the Contest and more specifically your full name (as it appears on your Instagram profile).

If you are one of the lucky winners, then in order to receive the gift, we will contact you and ask you for the following additional information:

- full name
- mobile phone number
- e-mail address
- home address

We collect this information directly from you and not from third parties.

Purpose and Legal basis of processing

Fraport Greece will process the above data, which are necessary for your participation in the Contest in accordance with its terms and conditions (processing necessary for the performance of the contract). In addition, the names of the winners will be published on Fraport Greece's official Instagram account for transparency and communication purposes.

Instagram Contest

Participation in the Contest is made using your "Instagram" social media account. Instagram does not relate, manage, promote or endorse this Contest in any way. Fraport Greece does not under any circumstances become a joint controller with Instagram, and bears no responsibility for the non-compliance of the aforementioned social networking tool with the European legislation on personal data as regards the processing of your personal data for purposes determined entirely by Instagram. Who we share your personal data with

For the best possible fulfilment of the above processing purpose, Fraport Greece may disclose your personal data to a collaborating advertising company for the fulfilment of this Contest and to any other administrative, judicial or public authority or any other legal or natural person, to whom Fraport Greece may have a legal obligation or right to disclose such data under the law or a court decision.

How long your data will be kept

The personal data processed by Fraport Greece is kept for as long as necessary to fulfil the purpose of the processing. Upon completion of the Contest and receipt of the gifts, data will be deleted, unless

otherwise specified by law or if this is required for the establishment, exercise or support of legal claims by Fraport Greece.

Personal Data Security

Fraport Greece takes all necessary technical and organizational security measures as required by law and the context of its business activity to protect personal data from unauthorized access, use, alteration and/or disclosure. We do our best to ensure that we only use your personal information as described in this privacy statement and we respect your choices. We only work with service providers who commit in writing to provide the same level of information security as Fraport Greece.

Your rights

In any case, we would like to inform you that, according to the applicable legislation, you have and can exercise the following rights after confirming your identity:

- the right to access your personal data, as well as information relating to the processing;
- the right to correct inaccurate and complete any incomplete data;
- the right to be deleted (“right to be forgotten”);
- the right to restrict the processing of your data in the cases expressly provided for by law;
- the right to portability of your data in a structured, commonly used and machine-readable format (e.g. USB), either to you or to another controller;
